### AN ACT

To amend Sections 3.(d), 12.B., 12.C., and 13.A. of Koror State Public Law Number K8207-2009, the Rock Islands Management and Conservation Act, and for related purposes.

# THE PEOPLE OF KOROR REPRESENTED IN THE LEGISLATURE OF THE STATE OF KOROR DO ENACT AS FOLLOWS:

#### Section 1. Findings.

The people of Koror, represented by the Eighth Koror State Legislature, find that 2 because Visitors to Palau from the Federated States of Micronesia, the Republic of the 3 Marshall Islands, and the United States of America, are currently being granted tourist 4 and business visas for entry into Palau for a period of one year instead of thirty days, it is 5 therefore necessary to amend the definition of "Resident Alien" and the requirements for 6 7 obtaining a "Resident Identification Card" in Koror State Public Law Number K8-207-2009, the Rock Islands Management and Conservation Act, in order to prevent Visitors 8 9 from these countries from possibly avoiding the requirement to obtain a Rock Island 10 Use permit or a Jellyfish Lake permit for the purpose of enjoying the waters of Koror 11 State. The Legislature further finds, pursuant to the request from the Department of Conservation and Law Enforcement, that it would assist the enforcement of this Act to 12 require Tour Guides, as well as Boat Operators, to maintain a passenger list, and that 13 14 this list include the Visitor's permit number.

# 15 Section 2. Amendment of Section 3.(d) of Koror State Public Law No. K8-2072009. Section 3.(d) of Koror State Public Law No. K8-207-2009 is amended to read:

For purposes of this definition, neither a tourist visa (B2) nor a business visa (B1) provide evidence of residency."

6 Section 3. Amendment of Section 12.B of Koror State Public Law No. K8-2077 2009.

Section 12.B. of Koror State Public Law No. K8-207-2009 is amended to read:

"B. Resident Aliens must have in their possession written proof of identification 9 10 to engage in any of the activities listed in section 6.A. or to visit any of the Rock Islands, 11 and must provide this proof of identification for inspection by Koror State law 12 enforcement personnel upon request. Failure to provide proof of identification 13 establishes the presumption that the person is a Visitor and will subject the person to the same requirements and penalties that apply to Visitors under this Act. Written 14 15 proof of identification shall be satisfied proven either by a valid work permit, or a current "Resident Identification Card" as described in Section 13, which must be in the 16 17 possession and control of the Resident Alien at all times. Neither a Tourist Visa (B2), 18 nor a Business Visa (B1), may be used to provide written proof of identification, no 19 matter how many days they are issued for."

"Section 13.A. of Koror State Public Law No. K8-207-2009 is amended to read:

"A. In order to satisfy the requirement of possession of written proof of 7 identification, a Resident Alien may purchase a "Resident Identification Card" from 8 9 Koror State. To purchase this card the Resident Alien must bring to the Koror State 10 Finance Office a current passport and visa authorizing entry into Palau for a period in 11 excess of ninety days or United States military orders authorizing entry into Palau for a 12 period in excess of ninety days. In addition, the Resident Alien must bring a current 13 one square inch color photograph. The price of the card shall be \$5.00. For purposes of this Act, neither a tourist visa (B2) nor a business visa (B1) provide evidence of 14 15 residency and neither will be accepted by the Koror State Finance Office as proof of residency in order to obtain a Resident Identification Card unless presented along with 16 17 some additional written form of identification or evidence establishing physical 18 presence and residency such as a current Work Permit card, Entry Permit card, a lease 19 of property for use as a residence, or proof of renting residential property which is the 20 place of abode of the applicant, or Palauan driver's license, or such other evidence to 21 establish residency, physical presence, and place of abode as may be required by the 22 Governor or his designee."
