

NOW THEREFORE BE IT ORDAINED by the the Council of the Municipal of Koror that the aggregate sum of fifteen thousand five hundred and two dollars (\$15,502,(00), or so much thereof as may be necessary, is hereby appropriated from current revenue together with any cash balance at the end of Fiscal Year 1963 for expenditures by Municipality of Koror for the purposes hereinafter stated and subject to conditions hereinafter set forth, during the fiscal year beginning July 1, 1963 and ending June 30, 1964.

Section 1. The sum of \$4,485.00 shall be set aside for Administrative salaries to be paid as follows:

- a. Magistrate (\$75.00 bi-weekly) \$1,950.00 per annum
- b. Clerk-Treasurer (\$42.50 bi-weekly) \$1,105.00 per annum
- c. Tax-Collector (\$32.50 bi-weekly) 845.00 per annum
- d. Census Clerk (\$22.50 bi-weekly) 585.00 per annum

Section 2. The sum of \$3,577.00 shall be set aside for the honorarium of Chief, Hamlet Chiefs, Council-men and Congress-men to be paid as follows:

- a. High Chief (\$ 50.00 per month) \$ 600.00 per annum
- b. 8 hamlet Chiefs (\$ 8.00 per month) per person ) \$ 768.00 per annum
- c. Congressmen (\$100.00 per year per person) \$1,000.00 per annum
- d. Councilmen (\$ 3.00 per person attending meeting.) \$1,209.00 per annum

Section 3. The sum of \$200.00 shall be set aside for the purchases of Administration stationery and office supplies.

- Section 4. The sum \$680.00 shall be set aside for the purchases of office equipment.
- Section 5. The sum of \$150.00 shall be set aside for the rental of boat or vehicle.
- Section 6. The sum of \$120.00 shall be set aside for the general maintenance.
- Section 7. The sum of \$250.00 shall be set aside for the Special Committee of the Municipal Office.
- Section 8. The sum of \$2,000.00 shall be set aside for the Road Improvement.
- Section 9. The sum of \$180,00 shall be set aside for Election.

Section 10. The sum of \$60.00 shall be set aside for  
Electricity rental  
for Public Elementary School and Municipal Office.

Section 11. The sum of \$2,000.00 shall be set aside for Koror  
Elementary School General Improvement fund.

Section 12. The sum of \$300.00 shall be set aside for  
Elementary School  
Office supplies or equipment.

Section 13. The Sum of \$1,500.00 shall be reserve for Koror  
New  
Elementary School construction.

BE IT FURTHER ORDAINED that al previous appropriation and  
expenditures ordinances and amendments thereto of the  
Municipality of Koror in conflict with the provisions contained  
herein are hereby revoked and superseded by, this ordinance.
